GIBRALTAR PILOTAGE (AMENDMENT) REGULATIONS 2017

In exercise of the powers conferred on him by section 30, read with sections 27 and 28, of the Gibraltar Pilotage Act 2016, the Minister has made the following Regulations:

Title and commencement.

1. These Regulations may be cited as the Gibraltar Pilotage (Amendment) Regulations 2017 and come into force on the 1st May 2017.
