#### **GIBRALTAR PILOTAGE ACT 2016**

### **GIBRALTAR PILOTAGE (AMENDMENT) REGULATIONS 2020**

In exercise of the powers conferred on him by section 30 of the Gibraltar Pilotage Act 2016 and all other enabling powers the Minister has made the following Regulations—

#### Title and commencement.

1. These Regulations may be cited as the Gibraltar Pilotage (Amendment) Regulations 2020 and come into operation on the 1st April 2020.

### **EXPLANATORY MEMORANDUM**

These Regulations amend the Gibraltar Pilotage Regulations 2016 in order to effect annual review of pilotage fees and the boarding, landing and other charges under regulations 27 and 28.
