Copy of an Entry in the Register of Gibraltarians Pursuant to the Gibraltarian Status Act.

Title.

1. These Rules may be cited as the Register of Gibraltarians Rules.

Form of register.

2. The register shall be maintained by the registrar in the form set out in Schedule 1.

Certificate of registration.

3. The registrar shall supply, on being so required, to any person whose name is entered in the register, a certificate of registration, in the form set out in Schedule 2 and certified in the manner specified therein.

Copy of entry.

4. The register shall supply to any person, on being so requested, a copy of an entry in the register, in the form set out in Schedule 3 and certified in the manner specified therein.

Search of register.

5. The register shall be open to inspection, upon prior payment of the fee prescribed by rule 10, by any person.

Copies of register.

6. There shall be maintained by the registrar additional copies of the register, in such form as the registrar may decide, which shall be kept in safe custody as follows:-

- (a) one copy by the Deputy Governor;
- (b) one copy by the Commissioner of Police.

Application to register under section 5.

7. (1) Any application made to the registrar under section 5 of the Act shall set out such facts as are necessary to enable the registrar to determine whether or not the applicant is entitled to be registered under section 5 of the Act.

(2) Any application made to the registrar under section 5 of the Act may be made either by the person applying for Registration or by any other person on his behalf.

Registrar may call for evidence.

8. The registrar may call for such further evidence (whether by way of statutory declaration or otherwise) as he thinks fit in connection with any application for registration.

Refusal to register.

9. The registrar shall, if he refuses to register any person who has applied to be registered under section 5 of the Act, forthwith notify such person of his refusal in writing.

Fees.

10.(1) There shall be payable to the Registrar the following fees:

- (a) For every certificate of registration (in the form set out in the Second Schedule) £1
- (b) For every copy of an entry (in the form set out in the third Schedule) £1.50
- (c) For every general search of the Register, per hour or part of an hour £3.00
- (d) For every search of a particular entry in the Register
... .. 50p.

(2) Notwithstanding sub-rule (1):-

- (a) where a certificate or copy of an entry is ordered at the same time as the search relating to it is made, no search fees shall be payable;
- (b) the fees payable thereunder may be waived in cases of hardship by the registrar.
