AN ORDINANCE to amend the Immigration Control Ordinance to transpose into the law of Gibraltar Council Directive 2002/90/EC defining the facilitation of unauthorised entry, transit and residence.

 E_{NACTED} by the Legislature of Gibraltar.

Title and Commencement.

1. This Ordinance may be cited as the Immigration Control (Amendment) Ordinance 2004 and comes into operation on 4 December 2004.

Amendment of the Immigration Control Ordinance.

- 2.(1) The Immigration Control Ordinance is amended in accordance with the provisions of this section.
- (2) The following is substituted for section 63A (1)–
 - "63A(1) The following persons are guilty of an offence and liable on summary conviction to imprisonment for up to three months or to a fine up to level 4 on the standard scale—
 - (a) a person who, intentionally, assists a person who is not a national of a Member State of the European Union to enter or to transit across the territory of a Member State in breach of the immigration law of that State;
 - (b) a person who, for financial gain, intentionally assists a person who is not a national of a Member State of the European Union to reside within the territory of a Member State in breach of that state's immigration law;
 - (c) a person who attempts, aids, abets, counsels or procures the commission of an offence under (a) or (b).".
- (3) After section 63A(2) insert the following-
 - "(3) In subsection (1) "immigration law" means a law which has effect in the relevant State and which controls, in respect of some or all persons who are not nationals of that State, entitlement to—
 - (a) enter the State;
 - (b) transit across the State; or

- (c) be in the State.
- (4) A document issued by the government of a state specified in Schedule 3 certifying a matter of law in that state—
 - (a) shall be admissible in proceedings for an offence under this section; and
 - (b) shall be conclusive as to the matter certified.".
- (4) A new Schedule 3 is inserted as follows-

"SCHEDULE 3

Facilitating entry into or residence in another country

Section 63A

- 1. For the purpose of this Schedule "Member State of the European Union" means a state or territory which is part of the European Union.
- 2. The countries referred to in section 63A are-
 - (a) Member State of the European Union;
 - (b) Iceland; and
 - (c) Norway."
