IMMIGRATION, ASYLUM AND REFUGEE ACT

UKRAINE (TRAVEL RESTRICTIONS) (AMENDMENT) (No.7) REGULATIONS 2014

In exercise of the powers conferred on him by section 52A of the Immigration, Asylum and Refugee Act, and for the purposes of implementing Council Decision 2014/855/CFSP of 28 November 2014, the Minister has made the following Regulations—

Title and commencement.

1. These Regulations may be cited as the Ukraine (Travel Restrictions) (Amendment) (No.7) Regulations 2014 and come into operation on the day of publication.

Amendment to the Annex.

2. The Schedule to the Ukraine (Travel Restrictions) Regulation 2014 (and which reproduces Council Decision 2014/145/CFSP) is amended as follows—

(a) in the Annex, the following entries are added to the list of persons—
