#### IMMIGRATION, ASYLUM AND REFUGEE ACT

## UKRAINE (TRAVEL RESTRICTIONS) (AMENDMENT) (NO 17) REGULATIONS 2018

In the exercise of the powers conferred upon him by section 52A of the Immigration, Asylum and Refugee Act, and for the purposes of implementing Council Decision (CFSP) 2018/392 of 12 March 2018 amending Decision 2014/145/CFSP concerning restrictive measures in respect of actions undermining or threatening the territorial integrity, sovereignty and independence of Ukraine, the Minister has made the following Regulations-

#### Title.

1. These Regulations may be cited as the Ukraine (Travel Restrictions) (Amendment) (No17) Regulations 2018.

#### Commencement.

2. The Regulations shall come into operation on the day of publication.

#### Amendment to the Ukraine (Travel Restrictions) Regulations 2014.

The Annex to the Ukraine (Travel Restrictions) Regulations 2014 which reproduces Council Decision 2014/145 (CFSP) is amended as follows-

These Regulations implement Council Decision (CFSP) 2018/392 of 12 March 2018 amending Decision 2014/145/CFSP concerning restrictive measures in respect of actions undermining or threatening the territorial integrity, sovereignty and independence of Ukraine.
