IMMIGRATION, ASYLUM AND REFUGEE ACT

UKRAINE TRAVEL RESTRICTIONS (AMENDMENT) (NO 20) REGULATIONS 2018

In exercise of the powers conferred on him by section 52A of the Immigration, Asylum and Refugee Act, and for the purposes of implementing Council Decision (CFSP) 2018/1237 of 12 September 2018 amending Decision 2014/145/CFSP concerning restrictive measures in respect of actions undermining or threatening the territorial integrity, sovereignty and independence of Ukraine, the Minister has made the following Regulations-

Title.

1. These Regulations may be cited as the Ukraine (Travel Restrictions) (Amendment) (No.20) Regulations 2018.

Commencement.

2. These Regulations shall commence on the day of publication.

Amendment to the Ukraine (Travel Restrictions) Regulations 2014.

3. The Schedule to the Ukraine (Travel Restrictions) Regulations 2014 is amended in accordance with the provisions of regulations 4 and 5.

Amendment to Article 6.

4. In Article 6, the second paragraph is replaced with the following-

"This Decision shall apply until 15 March 2019.".

Amendment to the Annex.

5. The Annex (which reproduces Council Decision 2014/145 CFSP) is amended by substituting the entries corresponding to the following persons and entities with-
