#### Title.

"17. Other dutiable goods not otherwise enumerated in the Schedule when exported on a commercial basis or in commercial quantities.

- (2) Schedule 1 of the Import Duty (Franchise) Regulations 1993 is amended by repealing paragraph 3(v).
- (3) Schedule 1 of the Import Duty (Franchise) Regulations 1993 is amended by inserting a new paragraph 18 as follows -

"18 Tobacco exported in bulk duly manifested

5% ad valorem".

### Amendments to Schedule 2.

## Title and Commencement.

#### PUBLIC HEALTH ORDINANCE

## BUILDING WORKS (HOARDINGS) RULES 1994 (AMENDMENT) RULES 1997

In exercise of the powers conferred on him by sections 42 and 337 of the Public Health Ordinance, the Governor has made the following Rules -

#### Title.

1. These Rules may be cited as the Building Works (Hoardings) Rules 1994 (Amendment) Rules 1997.

## Amendment to the Building Works (Hoardings) Rules 1994

- 2.(1) The Building Works (Hoardings) Rules 1994 shall be amended in rule 11 as provided in this rule.
- (2) Paragraph (a) of sub-rule (1) shall be amended by inserting after the words "is deferred" the words "subject to a maximum of £5000".
- (3) For paragraph (b) of sub-rule (1) there shall be inserted the following paragraph -
  - "(b) where no part of a street, court or public place is obstructed, £0.25 per linear metre for each day of the period specified in the notice issued under rule 3(4) or the days by which the date for removal of the hoarding is deferred, subject to a maximum of £5000.".(4) Sub-rule (2) shall be amended by substituting for the words "a fee of twice the rate specified in sub-rule (1)" the words "a penalty of £20 per day or part thereof for every day that the hoarding remains in place".

## EXPLANATORY MEMORANDUM

(This note does not form part of the Rules)

The purpose of these Rules is to place a limit of £5000 to the fees payable for the purposes of rules 3(4) and 10(3) of the Building Works (Hoardings) Rules 1994. The Rules also amend rule 11 of the Building Works (Hoardings) Rules 1994 so as to impose a £20 daily fine for every day or part thereof that a hoarding remains in place contrary to the provisions of the Rules.
