INTEGRATED TARIFF (AMENaDMENT NO.3) REGULATIONS 2019

In exercise of the powers conferred on it by sections 45 and 129 of the Imports and Exports Act, 1986, and all other enabling powers, the Government has made the following Regulations—

Title.

1. These Regulations may be cited as the Integrated Tariff (Amendment No.3) Regulations 2019.

Commencement.

2. These Regulations shall come into operation on the day of publication.

Amendment of the Integrated Tariff Regulations 2017.

- 3.(1) Schedule 1 to the Integrated Tariff Regulations 2017 is amended in accordance with this regulation.
 - (2) In Chapter 39
 - (a) under the heading "National Notes", after paragraph 3 insert—
 - "4. Unused plastic bags made wholly or partly from plastic and of a thickness of less than 100 microns as described in paragraph 20 of Schedule 1 to the Imports and Exports (Control) Regulations, 1987 are prohibited, subject to the exceptions set out therein.";
 - (b) for the entries marked "3923 21 10" to "3923 29 99" substitute –

EXPLANATORY MEMORANDUM

These Regulations amend the Integrated Tariff Regulations 2017 to reflect amendments made by the Imports and Exports (Control) (Amendment No.3) Regulations 2019 on the prohibition of unused plastic bags made wholly or partly from plastic and of a thickness of less than 100 microns.
