## IMPORTS AND EXPORTS ACT, 1986

### INTEGRATED TARIFF (AMENDMENT No. 3) REGULATIONS 2022

In exercise of the powers conferred upon it by sections 45 and 129 of the Imports and Exports, Act 1986, and all other enabling powers, the Government has made the following Regulations—

#### **Title.**

1. These Regulations may be cited as the Integrated Tariff (Amendment No. 3) Regulations 2022.

#### **Commencement.**

2.(1) Subject to subregulations (2) to (4), these Regulations come into operation on the day of publication.

(2) Regulation 3 comes into operation on 29<sup>th</sup> June 2022.

(3) Regulation 4 comes into operation on 1<sup>st</sup> July 2022.

(4) Regulation 5 comes into operation on the 1<sup>st</sup> October 2022.

#### **Amendment to Chapter 98 of the Integrated Tariff Regulations 2017.**

3.(1) Chapter 98 of Schedule 1 to the Integrated Tariff Regulations 2017 is amended in accordance with this regulation.

(2) In the entries marked “9848 00 00”, “9880 13 91”, “9880 17 90”, “9880 18 00” for the rate of duty specified in column 4 substitute “Free”.

(3) In the entries marked “9833 00 00”, “9862 00 00”, “9864 00 00”, “9871 00 00”, “9880 17 10”, “9891 00 00”, “9897 00 00” for the rate of duty specified in column 4 substitute “3”.

(4) In the entries marked “9880 13 10”, “9880 15 00”, “9880 16 00” for the rate of duty specified in column 4 substitute “6”.

(5) In the entries marked “9871 03 00”, “9880 11 00”, “9880 12 00”, “9880 13 99”, “9880 14 00”, “9880 19 00”, “9880 20 00”, “9880 21 00”, “9887 08 00”, “9894 00 00” for the rate of duty specified in column 4 substitute “12”.

**Extension of temporary amendment to Chapter 27.**

4. Chapter 27 of Schedule 1 to the Integrated Tariff Regulations 2017 is amended in the entries marked “2710 12 41”, “2710 12 45”, “2710 12 49”, “2710 12 51”, “2710 12 59”, “2710 19 43”, “2710 19 45”, “2710 20 11” and “2710 20 14” in column 4 by substituting the rate of duty with “£250/1000 l”.

**Amendment to Chapter 27 to revert to original rate.**

5.(1) Chapter 27 of Schedule 1 to the Integrated Tariff Regulations 2017 is amended in accordance with this regulation.

(2) In the entries marked “2710 12 41”, “2710 12 45”, “2710 12 51”, in column 4 by substituting the rate of duty with “£380/1000 l”.

(3) In the entries marked “2710 12 49”, “2710 12 59”, “2710 19 45”, “2710 20 14”, in column 4 by substituting the rate of duty with “£370/1000 l”.

(4) In the entries marked “2710 19 43” and “2710 20 11” in column 4 by substituting the rate of duty with “£400/1000 l”.

**Savings.**

6. The amendments to the Integrated Tariff Regulations 2017 made by regulation 4 does not affect the validity of anything done or not done pursuant to these Regulations.
