IMPORTS AND EXPORTS ACT, 1986

INTEGRATED TARIFF (AMENDMENT NO.4) REGULATIONS 2022

In exercise of the powers conferred on it by sections 45 and 129 of the Imports and Exports Act, 1986, and all other enabling powers, the Government has made the following Regulations-

Title.

1. These Regulations may be cited as the Integrated Tariff (Amendment No.4) Regulations 2022.

Commencement.

2. These Regulations come into operation on the day of publication.

Amendment to the Integrated Tariff Regulations 2017.

3.(1) The Integrated Tariff Regulations 2017 are amended in accordance with this regulation.

(2) In Schedule 1, in the entry for commodity number 9603 21 00, in column 4, for "12" substitute "3".

(3) In Schedule 3, for paragraph 5 substitute –

5. Products imported by or on behalf of a charity or cause approved in	Free
writing by the Collector for the purposes of this paragraph.	

(4) In Schedule 3, for paragraph 28 substitute-

28. Goods imported by a business that is licensed to trade in goods listed within this paragraph, as follows-	3%
Furniture and Furnishings;Domestic use vacuum cleaners and sewing machines;Electric toothbrushes; electric shavers; hair clippers; hair removing appliances;Table, floor, wall, window, ceiling or roof fans with an output not exceeding 125W.	

"

(5) In Schedule 3, for paragraph 36 substitute -

36. Electro-domestic appliances with an energy rating of A or higher for items labelled prior to 1 March 2021, or an energy rating of A, B, C or D for items labelled on or after 1 March 2021, imported by a business that is licensed to trade in such goods.

In this paragraph "electro-domestic appliances" means domestic use cookers (oven/hob/grill), refrigerators, freezers, combination fridgefreezers, washing machines, tumble driers, combination washer driers, dishwashers, electric instantaneous or storage water heaters and immersion heaters.

(6) In Schedule 3, after paragraph 46 insert -

47. Materials, components or other goods imported for manufacture,	Free
production or processing in Gibraltar for an industrial activity in respect	
of which the Minister for Finance has issued a certificate.	
48. Goods liable to import duty under Chapters 29 and 30 imported by	Free
a pharmacy registered and licensed under the Medical and Health	
Act,1997 and regulations made under it.
