IMPORTS AND EXPORTS ACT, 1986

INTEGRATED TARIFF (AMENDMENT) REGULATIONS 2023

In exercise of the powers conferred upon it by sections 45 and 129 of the Imports and Exports, Act 1986, and all other enabling powers, the Government has made the following Regulations—

Title.

1. These Regulations may be cited as the Integrated Tariff (Amendment) Regulations 2023.

Commencement.

2. These Regulations come into operation on the day of publication.

Amendment of the Integrated Tariff Regulations 2017.

- 3.(1) The Integrated Tariff Regulations 2017 are amended in accordance with the provisions of this regulation.
- (2) In Chapter 24 -
 - (a) in the Subheading Note, after paragraph 1, insert the following new note-
 - "2. For the purposes of heading 24.04, the expression "inhalation without combustion" means inhalation through heated delivery or other means, without combustion.".
 - (b) after the entry marked "2403 99 99" insert the following entry-
