LICENSING AND FEES ACT.

LICENSING AND FEES (AMENDMENT OF SCHEDULE) NOTICE 1987.

In exercise of the powers conferred upon him by Section 52 of the Licensing and Fees Act, the Governor with the prior approval of the House of Assembly has issued the following notice:

Title and commencement.

- 1.(1) This notice may be cited as the Licensing and Fees (Amendment of Schedule) Notice, 1987.
- (2) This notice shall come into operation on the day of its publication in the Gazette, except sections 3 and 4 which shall come into operation on the 1st day of April 1987.

Amendment of passport fees.

2. Schedule 2 to the licensing and Fees Act is amended in Item 5. Passport Fees, Paragraph (j), by omitting the expression "£21.50" in both places where it appears and substituting therefor the expression "£26.00".

Abolition of Wharfage Charges.

3. The said Schedule 2 is further amended by repealing Item 9, Wharfage Charges.

Amendment of Rental Charges.

- 4. The said Schedule 2 is further amended in Item 9A, Rental Charges-
 - (a) by renumbering the Item as Item 9;
 - (b) by repealing paragraph (1) and substituting therefor the following new paragraph-

- "(1) Rental charges shall be paid in respect of every container anywhere within the Port, other than in a Government store, as follows-
 - (i) containers up to 25 feet in length: the first thirty days including the day of discharge-free thereafter for each succeeding day or part thereof, £10;
 - (ii) containers exceeding 25 feet in length: the first thirty days including the day of discharge five; thereafter for each succeeding day or part thereof, £20
- (c) in paragraph (1A) by substituting for the reference to paragraph (1)(a) a reference to paragraph (1);
- (d) in paragraph (1B)-
 - (i) by omitting the words from "Notwithstanding" to "where" and substituting therefor the word "Where" and
 - (ii) by omitting the word "seven" and substituting therefor the word "thirty"
 - (e) in paragraph (2) by omitting the expression "and Item 9";
 - (f) by repealing paragraph (3) and substituting therefor the following new paragraph-
 - "3. Charges under this Item shall be payable by the owner of the container or the owner's representative in Gibraltar and both the owner and the representative shall be jointly and severally liable for the payment of such charges."
- (g) by repealing paragraph (4) and substituting therefor the following new paragraph-

"(4) Any rental charges due under this Item may be recovered summarily by the Captain of the Port as a civil debt notwithstanding that the container has not been removed from the Port;

Provided that in the case of a container which has not been removed from the Port no proceedings shall be instituted unless and until rental charges of more than f100 are due or would have been due but for the fact that they have been reduced below that figure by reason of a sale under paragraph (5);"

- (h) in paragraph (5) by omitting the words "or wharfage" in both places where they appear;
- (i) in paragraph (7) by omitting the expression "and Item 9".
