LICENSING AND FEES ORDINANCE

LICENCE (FEES) RULES 1991 (AMENDMENT) RULES 2002

In exercise of the powers conferred on him by section 51 of the Licensing and Fees Ordinance the Governor has made the following rules—

Title and Commencement.

1. These rules may be cited as the Licence (Fees) Rules 1991 (Amendment) Rules 2002, and come into operation on 1 April 2002.

Amendment of Schedule 2 Paragraph 5 of the Licensing (Fees) Rules 1991.

- 2. Schedule 2 of the Licensing (Fees) Rules 1991 shall be amended in paragraph 5 (Passport fees) as follows—
 - (a) Sub-paragraphs (a) (i) and (ii) shall be amended by substituting for the figures "£21.00" and "£11.00" the figures "£30.00" and "£16.00" respectively.
 - (b) For sub-paragraph (d) there shall be substituted the following paragraph—
 - "(d) for amending an existing passport by amending the holders name and or national status at the request of the holder, or issuing a replacement passport which contains such amendment

18.00"

(c) Sub-paragraph (e) shall be amended by substituting for the figures of £11.00 the figures £18.00.

- (d) For sub-paragraph (k) there shall be substituted the following sub-paragraph-
 - "(k) Receiving an application for an entry clearance for the United Kingdom under the following categories—
