### Title.

1. These Regulations may be cited as the Litter Control (Forms and Notices) Regulations, 1990.

#### **Designation Orders.**

2. (1) Where a Litter Authority proposes to issue a designation order under sub-section (3) of Section 7 of the Act, the notification required by sub-section (5) of that Section shall be in the form prescribed in Part 1 of Schedule 1 to these Regulations.

(2) Where a Litter Authority issues a designation order under section 7(3) of the Act, such order shall be in the form prescribed in Part 2 of Schedule 1 of these regulations.

#### Lifter Abatement Notice.

3. (1) Where a Litter Authority serves a notice in accordance with section 9(1) of the Act, such notice (a "litter abatement notice") shall be in the form prescribed in Part 1 of Schedule 2 to these regulations.

(2) Where a Litter Authority proposes to exercise its powers of removal under section 9(6) of the Act, a notice in the form prescribed in Part 2 of Schedule 2 to these regulations shall be issued.

#### LITTER CONTROL ACT, 1990.

- (i) The person served with this notice may appeal against the notice to the Magistrates' Court within the period of seven days. beginning with the date- on which the. notice was served,
- (ii) A person who, without reasonable excuse, fails to comply with or contravenes the requirements of the notice, shall be guilty of an offence and liable on summary conviction to a fine not exceeding  $\pounds 2,000$  and a further fine of 1100 for each day on which the offence continues after the conviction.
- (iii) If any person fails to comply with this Notice, the Litter Authority may, where it considers it necessary in the interests of the amenities of the neighbourhood, remove the litter or refuse in respect of which the notice was issued and any person subsequently convicted in this respect shall be liable to the Authority for the reasonable cost of such removal.
