## Gibraltar Health Authority (Transfer of Functions) Regulations, 1988

#### **Title and Commencement**

- 1.(1) These regulations may be cited as the Gibraltar Health Authority (Transfer of Functions) Regulations, 1988.
- (2) The provisions of these regulations, other than those in Parts V and VI, shall come into operation on the 1st day of February, 1988, and those regulations in Parts V and VI shall come into operation on the 31st day of March, 1988.

#### PART I: THE ANIMALS AND BIRDS ACT.

### Amendment of the Animals and Buds Rules

2. The Animals and Birds Rules are amended by deleting the words "Director of Medical and Health Services" and "Director" in each place where they appear and substituting in each such place the words "Chief Environmental Health Officer.".
