Title.

1. These Rules may be cited as the Hospitals Rules.

Interpretation.

2. In these Rules, unless the context otherwise requires, –

"accommodation" includes, nursing, dressings, medicines and food;

"Board" means the Board of Management for the Medical and Health Services established under section 70 of the Ordinance;

"entitled person" means –

- (a) a person registered as a member of the Medical Group Practice Scheme, or a dependant of such a person, in accordance with section 3(2) of the Medical (Group Practice Scheme) Ordinance;
- (b) Omitted
- (c) *Omitted*
- (d) a national of a Member State of the European Economic Community who is in possession of Form E111 issued by the competent authority of the Member State of the Community of which he is a national (hereinafter referred to as "an EEC national");

hospital means any hospital provided or maintained by the Authority;

"non-entitled person" means any person other than an entitled person;

"patient" includes an expectant or nursing mother;

"school age" means the upper limit of compulsory school age as prescribed by or under the Education Ordinance².

Admission of patients.

HOSPITALS RULES.

- 3.(1) Any entitled person who, in the opinion of the Specialist in Community Medicine, is in need of hospital treatment, shall be entitled to be admitted to a hospital either as an in-patient or as an out-patient for the purpose of receiving such treatment.
- (2) Save in cases of emergency, no non-entitled person shall be admitted to a hospital for the purpose of receiving medical attention or treatment, as an in-patient or as an out-patient, without the permission of the Specialist in Community Medicine, and the Specialist in Community Medicine may grant or refuse such permission in his discretion.

Fees payable by in-patients.

- 4.(1) In respect of an entitled person admitted to a public ward, there shall be payable the fees set out in the first column of Schedule 1.
- (2) In respect of an entitled person admitted to a private ward, there shall be payable the fees set out in the second column of Schedule 1.

Provided that an entitled person coming within subparagraph (d) of the definition of "entitled person" contained in Rule 2 shall pay fees as a non-entitled person when in a private ward.

- (3) In respect of a non-entitled person admitted to a private ward, there shall be payable the fees set out in the third column of Schedule 1.
- (4) Any patient admitted in the first instance to a public ward, who, within three weeks of such admission, is at his own request transferred to a private ward shall pay the fees set out in the second or third column of Schedule 1 for services (other than accommodation) payable in respect of a private ward as from the date of admission to the public ward.
- (5) Where any operation is performed on any patient, the General Manager may in his discretion upon being satisfied that in the circumstances of the case it is equitable so to do, direct that the fee to be charged in respect of that operation shall be such as he certifies to be the correct sum payable.

Fees payable by out-patients.

5. For every attendance or treatment of an entitled or non-entitled person as an out-patient at any dispensary or clinic conducted at or in connection with a hospital there shall be payable the fees set out in Schedule 1, as the case may be:

Provided that:-

(a) the General Manager may, because of the financial circumstances of the out-patient or of any person liable for the payment of the fees, remit the fees in whole or in part;

(b) no fee shall be payable by any entitled person, who is not a private patient, in respect of any attendance at an ante-natal clinic.

Pathology.

- 6. In respect of any patient for pathological examinations there shall be payable the fees set out in Schedule 1.
- 7. Revoked

No fee payable in certain cases.

- 8. Notwithstanding any other provision of these rules, no fee shall be charged
 - (a) in respect of an entitled person suffering from an infectious disease whose admission to a hospital is deemed by the Specialist in Community Medicine to be in the interests of public health and who is accommodated in a public ward; or
 - (b) in respect of treatment for venereal disease of any person eligible for treatment as an out-patient or an in-patient and who is accommodated in a public ward.

Private ward for confinement.

9. Any person requiring a private ward for a confinement shall make application therefor in the form set out in Schedule 5.

Payment and recovery of fees.

- 10. (1) The fees payable in accordance with these rules shall be due and payable on demand.
- (2) Save in cases of emergency, any fee which may be charged in respect of any out-patient under the provisions of rule 5 shall be paid before that person shall be entitled to receive any medical attendance at a dispensary or clinic.
- (3) The General Manager may require that, in respect of any person who has applied to be admitted to a hospital as an in–patient there shall be given such security as the General Manager may deem sufficient for the payment of any fees which may become payable in respect of such person under the

provisions of these rules, and the General Manager may refuse to admit to the hospital any such person in respect of whom such security has not been given.

(4) All sums due and remaining unpaid in respect of fees prescribed by these rules shall be recoverable ... as a civil debt by the Authority from the person in respect of whom they are payable or from any person who is responsible for the payment of such fees or on whose application that person was admitted to the hospital or who was provided with any treatment specified in the Schedules.

11. Revoked

Assessment of accommodation fees.

12. In assessing the fees due under these rules in respect of accommodation the day of admission and the day of discharge shall be treated as a single day.

Removal of patients from hospital in certain cases.

13. Any person who enters a hospital for any reason whatsoever may be removed therefrom by direction of the General Manager if he fails to comply with any directions given to him by a medical officer or if his conduct is such that, in the opinion of the General Manager his continued presence in the hospital is prejudicial to the

comfort or well being of other patients or to the general administration of the hospital.

Remission of fees.

14. The Authority may for any good cause shown remit any fees payable under these rules, in whole or in part.

Visits to patients.

15. Visits to patients in a hospital may be made only at such times and for such periods as the Board may direct.

Delegation of powers.

16. The General Manager may delegate in writing all or any of the powers vested in him by these rules.

Classification of patients.

17. The General Manager shall decide whether any person is an entitled person or a non-entitled person.
