### Title.

1. These Regulations may be cited as the Register of Nurses, Midwives and Health Visitors Regulations 1997.

### Interpretation.

2. In these Regulations "the Board" means the Nurses, Midwives and Health Visitors Registration Board established under section 25 of the Act.

### Register to be divided into Parts.

3. The register required to be kept by the Board under section 28 of the Act shall be in nine parts as follows –

### PART I

First level Nurses registered under the provisions of section 29, 30, 31 or 32 of the Act.

### PART II

Enrolled Nurses registered under the provisions of section 28 of the Act.

#### **PART III**

First level nurses trained in mental health nursing and registered under the provisions of section 29, 30, 31 or 32 of the Act.

#### PART IV

Enrolled nurses trained in mental health nursing and registered under the provisions of section 28 of the Act.

#### PART V

First level nurses trained in mental handicap and registered under the provisions of section 29,30, 31 or 32 of the Act.

#### PART VI

Enrolled nurses trained in mental handicap and registered under the provisions of section 28 of the Act.

### PART VII

Nurses trained in nursing of sick children and registered under the provisions of section 29, 30, 31 or 32 of the Act.

#### PART VIII

Midwives registered under the provisions of section 29, 30, 31 or 32 of the Act.

#### PART IX

Health visitors registered under the provisions of section 29, 30 and 31 of the Act.

#### **Registration of Nurses.**

4.(1) A person who has undergone such training and passed such examination as may be prescribed by the Board for first level nurses other than those referred to in sub-regulations (3), (5) and (7) of this regulation, shall be registered in Part I of the register.

(2) A person who has undergone such training and passed such examination as may be prescribed by the Board for enrolled nurses other than those referred to in sub-regulations (4) and (6) of this regulation, shall be registered in Part II of the register.

(3) A person who has undergone such training and passed such examination as may be prescribed by the Board for first level nurses trained in mental health shall be registered in Part III of the register.

(4) A person who has undergone such training and passed such examination as may be prescribed by the Board for enrolled nurses trained in mental health nursing shall be registered in Part IV of the register.

(5) A person who has undergone such training and passed such examination as may be prescribed by the Board for first level nurses trained in mental handicap shall be registered in Part V of the register.

(6) A person who has undergone such training and passed such examination as may be prescribed by the Board for enrolled nurses trained in mental handicap shall be registered in Part VI of the register.

(7) A person who has undergone such training and passed such examination as may be prescribed by the Board for nurses trained in nursing of sick children shall be registered in Part VII of the register.

(8) A person who has undergone such training and passed such examination as may be prescribed by the Board for midwives shall be registered in Part VIII of the register.

(9) A person who has undergone such training and passed such examination as may be prescribed by the Board for health visitors shall be registered in Part IX of the register.

#### **Registration Fee.**

5.(1) The fee for the registration of nurses in the register under section 29(1) and (2), 30, 31, or, as the case may be, 32 of the Act, for each 36 month period of part thereof, shall be £30.00.

(2) The fee for further registration of nurses in the register under section 29(3) of the Act, for each 36 month period or part thereof, shall be £15.00.

(3) The fee for registration of midwives in the register under section 29(1) and (2), 30, 31, or, as the case may be, 32 of the Act, for each 36 month period or part thereof, shall be £30.00.

(4) The fee for further registration of midwives in the register under section 29(3) of the Act, for each 36 month period or part thereof, shall be £15.00.

(5) The fee for registration of health visitors in the register under section 29(1), 30 or, as the case may be, 31 of the Act, for each 36 month period or part thereof, shall be £30.00.

(6) The fee for further registration of health visitors in the register under section 29(3) of the Act, for each 36 month period or part thereof, shall be  $\pm 15.00$ .

#### Certificate.

6.(1) Every person admitted to the register shall be given by the Board a certificate in the appropriate form as set out in the Schedule to these Regulations.

(2) In the event of a certificate being lost or accidentally destroyed the holder may apply to the Board for a fresh certificate, and the Board may, if it thinks fit, grant such fresh certificate upon payment by the applicant of a fee of  $\pm 2.50$ . A certificate issued under this sub-regulation shall be marked "Duplicate".

#### **Change of Address.**

7. A person whose name is included in the register shall notify the Secretary of the Board of every permanent change of address as soon as possible. The address last notified shall be deemed to be the address for all purposes.
