### **Title**

1. These Regulations may be cited as the Medical (Group Practice Scheme) (Contributions) Regulations 2004 and come into operation on 3 January, 2005.

### **Weekly rates of contributions**

2. The weekly contributions referred to in section 5 of the principal Act are payable as follows -

- (a) employed persons aged 18 years or over other than persons mentioned in paragraph (c) -
  - (i) amount payable by employer - £11.20;
  - (ii) amount payable by employee - £18.60;
- (b) employed persons aged under the age of 18 years -
  - (i) amount payable by employer - £12.58;
  - (ii) amount payable by employee - £16.87;
- (c) employed persons who have exercised the option not to pay social insurance contributions -
  - (i) amount payable by employer - £11.20;
  - (ii) amount payable by employee - nil;
- (d) self employed persons - £14.96;
- (e) persons contributing to the Employment Injuries and Group Medical Practice Scheme only -
  - (i) amount payable by employer - £15.05;
  - (ii) amount payable by employee - £10.33.
