In exercise of the powers conferred on me by section 39(2) of the Mutual Legal Assistance (European Union) Act 2005 and all other enabling powers and in order to transpose into the law of Gibraltar Commission Directive 2006/84/EC of 23 October 2006 adapting Directive 2002/94/EC laying down detailed rules for implementing certain provisions of Council Directive 76/308/EEC on mutual assistance for the recovery of claims relating to certain levies, duties, taxes and other measures, by reason of the accession of Bulgaria and Romania, I make the following Regulations—

Title and commencement.

1. These Regulations may be cited as the Mutual Legal Assistance (European Union)(Bulgaria and Romania) Regulations 2007 and shall be deemed to have come into operation on 1 January 2007.

Amendments to the Mutual Legal Assistance (European Union) Regulations 2006.

- 2. The Mutual Legal Assistance (European Union) Regulations 2006 are amended as follows—
 - (a) for Schedule 4 substitute the new Schedule 4 set out in the Schedule to these Regulations;
 - (b) in Schedule 5-
 - (i) insert after paragraph (b)-
 - "(ba) Bulgaria;"; and
 - (ii) insert after paragraph (s)-

"(sa) Romania;".
