In exercise of the powers conferred upon it by section 18(1) of the Nature Protection Act 1991, and after consulting the Nature Conservancy Council, the Government has made the following Order–

#### Title and commencement.

1. This Order may be cited as the Nature Conservation (Designation of Gibraltar Nature Reserve) Order 2016 and comes into operation on the day of publication.

#### Designation of nature conservation area.

2(1). The area shaded in green in the plan shown as Figure 1 in the Schedule is designated as a nature conservation area and shall be known as the Gibraltar Nature Reserve.

#### **Revocation.**

3. Subject to paragraph 4, the Nature Conservation (Designation of Gibraltar Nature Reserve) Order 2013 is revoked.

#### Savings.

4. A person's liability for any act done within the area designated under the Nature Conservation (Designation of Gibraltar Nature Reserve) Order 2013 shall not be affected by the revocation under paragraph 3 if the act took place within the area that is also designated by this Order.
