## Nature Conservation (Designation of Gibraltar Nature Reserve and Upper Rock Nature Reserve) Order 2023

In exercise of the powers conferred upon it by section 18(1) of the Nature Protection Act 1991, and after consulting the Nature Conservancy Council, the Government has made the following Order—

#### Title.

1. This Order may be cited as the Nature Conservation (Designation of Gibraltar Nature Reserve and Upper Rock Nature Reserve) Order 2023.

#### Commencement.

2. This Order comes into operation on the day of publication.

#### Designation of nature conservation area.

- 3.(1) The area coloured red on the plan deposited in the offices of the Department of the Environment, shaded red in the map at Schedule 1 for illustration purposes, is designated as a nature conservation area and shall be known as the Gibraltar Nature Reserve: Devil's Tooth Green Corridor.
- (2) The area coloured yellow on the plan deposited in the offices of the Department of the Environment, shaded yellow in the map at Schedule 2 for illustration purposes, is designated as a nature conservation area and shall be known as the Upper Rock Nature Reserve.
- (3) The area coloured green on the plan deposited in the offices of the Department of the Environment, shaded green in the map at Schedule 3 for illustration purposes, is designated as a nature conservation area and shall be known as the Gibraltar Nature Reserve.

#### Revocation.


- 4.(1) Subject to paragraph 5, the Nature Conservation Area (Upper Rock) Designation Order 1993 is revoked.
- (2) Subject to paragraph 5, the Nature Conservation (Designation of Gibraltar Nature Reserve) Order 2019 is revoked.

#### Savings.

- 5. A person's liability for any act done or not done within the areas designated under the Nature Conservation Area (Upper Rock) Designation Order 1993 or the Nature Conservation (Designation of Gibraltar Nature Reserve) Order 2019 shall not be affected by the revocation under paragraph 4 if the acts took place within the areas that are also designated by this Order.


