#### PARLIAMENT ACT

## **ELECTORS (REGISTRATION) (AMENDMENT) RULES 2010**

In exercise of the powers conferred on him by section 25 of the Parliament Act the Minister with responsibility for elections has made the following Rules-

## Title and commencement.

1. These Rules may be cited as the Electors (Registration) (Amendment) Rules 2010 and come into operation on the date of publication.

### Amendment of the Electors (Registration) Rules.

2.(1) The Electors (Registration) Rules are amended in accordance with this rule.

(2) In rule 18(1)(b) for "a British citizen, a British Dependent Territories citizen, a British Overseas citizen or a British subject" substitute "a British citizen, a British Overseas Territories citizen, a British Overseas citizen, a British National (Overseas), a British protected person or a British subject under the British Nationality Act 1981".

(3) In the Schedule-

 (i) in Form RA for "a British citizen, British Dependent Territories citizen, British Overseas citizen or British subject under the British Nationality Act 1981" substitute "a British citizen, a British Overseas Territories citizen, a British Overseas citizen, a British National (Overseas), a British protected person or a British subject under the British Nationality Act 1981";

- (ii) in the declaration in Form RB1 for "a British citizen, British Dependent Territories citizen, British Overseas citizen or British subject under the British Nationality Act 1981" substitute "a British citizen, a British Overseas Territories citizen, a British Overseas citizen, a British National (Overseas), a British protected person or a British subject under the British Nationality Act 1981";
- (iii) in Form RB2 for "British citizen, British Dependent Territories citizen, British Overseas citizen or British subject under the British Nationality Act 1981" substitute "a British citizen, a British Overseas Territories citizen, a British Overseas citizen, a British National (Overseas), a British protected person or a British subject under the British Nationality Act 1981";
- (iv) in Form RD-
  - (a) in the first paragraph of Part 2 of the main text for "British citizen, British Dependent Territories citizen, British Overseas citizen or British subject under the British Nationality Act 1981" substitute "British citizen, British Overseas Territories citizen, British Overseas citizen, British National (Overseas), British protected person or British subject under the British Nationality Act 1981";
  - (b) in paragraph (b) of the main text for "British citizens, British Dependent Territories citizens, British Overseas citizens or British subjects under the British Nationality Act 1981" substitute "British citizens, British Overseas Territories citizens, British Overseas citizens, British Nationals (Overseas), British protected persons or British subjects under the British Nationality Act 1981";
  - (c) in Note 2 for "British citizens, British Dependent Territories citizens, British Overseas citizens or British subjects under the British Nationality Act 1981" substitute "British citizens, British Overseas Territories citizens, British Overseas citizens, British Nationals (Overseas), British protected persons or

British subjects under the British Nationality Act 1981".
