**POLICE ORDINANCE.**

**GIBRALTAR POLICE ASSOCIATION (AMENDMENT)  
REGULATIONS, 1994.**

In exercise of the powers conferred on me by section 52 of the Police Ordinance, and after having obtained the approval of the Governor, I have made the following regulations -

**Title and commencement.**

1. These regulations may be cited as the Gibraltar Police Association (Amendment) Regulations 1994 and shall take effect in respect of nomination for elections to take place in February, 1995.

**Amendment to regulation 5.**

2. Regulation 5 of the Gibraltar Police Association regulations (hereinafter called "the principal Regulations") is amended by inserting after subregulation (3) the following new sub-regulation -

"(4) The annual general meeting shall be held in the month of February in each year."

**Amendment to regulation 6.**

3. Regulation 6 of the principal Regulations is amended in sub-regulations (1) and (2) by omitting the word "retiring" in each place where it occurs.

**Amendment to regulation 7.**

4. Regulation 7 of the principal Regulations is amended -

- (a) by inserting after the figure "7" (the figure "(1)");
- (b) by inserting after sub-regulation (1), as now so designated; the following new sub-regulation -

"(2) A person elected in accordance with regulation 8 shall remain a member of the Council for a period of three years unless he shall have resigned from membership of the Council, and a member shall resign if he ceases to be a police officer or a police officer of the rank in respect of which he was elected:

Provided that -

(a) where a person is nominated by the Commissioner in exercise of his powers under regulation 8(4), that person shall be deemed for the purposes of this sub-regulation to have been elected; and

(b) where a person is nominated by the Commissioner in exercise of his powers under regulation 11, that person shall remain a member for the unexpired portion of the period of membership of the person of whom the vacancy has occurred."

**Amendment to regulation 8.**

5. Regulation 8 of the principal Regulations is amended -

- (a) in sub-regulation (1) by omitting everything after the word "rank" where it occurs for the second time and substituting therefor the following words -

"every third year not later than the 15th day of January and elections will take place at the annual general meeting of the Police Association next occurring after that date.";

- (b) in sub-regulation (2) -

(i) by inserting after the word "meeting" the words "referred in sub-regulation (1)";

(ii) by omitting the word "retiring";

(c) in sub-regulation (3) by inserting before the word "annual" the word "third".

**Amendment to regulation 9.**

6. Regulation 9 of the principal Regulations is amended by omitting the words "each year of office" and substituting therefor the words "each period of twelve months".

**Amendment to regulation 16.**

7. Regulation 16 of the principal Regulations is amended by omitting the word "retiring".
