#### PORT ORDINANCE

#### PORT (AMENDMENT) RULES 2006

In exercise of the powers conferred on him by section 19 of the Port Ordinance, and all other enabling powers, the Governor has made the following Rules:

#### Title and commencement.

- 1.(1) These Rules may be cited as the Port (Amendment) Rules 2006.
- (2) These Rules shall be deemed to have come into operation on 1 April 2005 except rules 4 and 5 which shall be deemed to have come into operation on 1 December 2005.

#### Insertion of rule 7B.

2. The Port Rules are amended by inserting the following rule after rule 7A-

#### "Crew, Passenger and Store declaration.

7B. A vessel that is a yacht shall make a Crew, Passenger and Store Declaration in the forms set out in Part III of Schedule 7.".

#### Substitution of rule 16A.

3. The Port Rules are amended by substituting the following rule for the rule 16A-

## "Reporting of yachts.

- 16A. Every yacht entering Gibraltar shall-
  - (a) in the first instance proceed directly to a commercial marina unless the Captain of the Port directs otherwise; and

(b) comply with the requirements of rule 7B.".

#### Amendment of Schedule 2.

- 4. Schedule 2 of the Port Rules is amended by inserting the following paragraph after paragraph 4-
- "5. A fee of £60.00 shall be charged for a passenger certificate issued pursuant to rule 72.";

#### Amendment of Schedule 4.

- 5. Schedule 4 of the Port Rules is amended by-
  - (a) substituting in paragraph 1(b)(i) the words "Minister with responsibility for the Port and Shipping" for the words "Minister with responsibility for Transport";
  - (b) amending in paragraph 3 as follows-
    - (i) the figure ".50" shall be substituted for the figure "£2" for a lighter, per tonnes deadweight; and
    - (ii) the figure ".50p" shall be substituted for the figure ".10p" for a carrier of petroleum, water or any other product, etc.; and
  - (c) inserting the following paragraphs after paragraph 7–

### "8. Space for storage.

A person who wishes to use any space for the storage of oil drums or anything else within the confines of the Port at a location approved by the Captain of the Port shall be liable to pay a fee @ £2.50 per sq.ft.

#### 9. Portacabins.

An operator wishing to have a portacabin shall be liable to pay a fee @ £2.50 per sq. ft.".

#### Amendment of Schedule 5.

- 6. Schedule 5 of the Port Rules is amended by inserting the following entry after entry No.  $8-\,$
- "9. Any vessel which enters the Port for being used only as a floating storage and that vessel is issued with a safety certificate and a petroleum licence."

## Amendment of Schedule 6.

- 7. Schedule 6 of the Port Rules is amended by substituting the following paragraph for paragraph 7-
- "7. The entire area lying to the East of the Longitude of "E" Head."

#### Amendment of Schedule 7.

8. Schedule 7 of the Port Rules is amended by inserting the following PART after PART II—  $\,$
