PORT (AMENDMENT NO.3) RULES 2024

In exercise of the powers conferred on it by section 19 of the Port Act, the Government has made the following Rules-

Title.

1. These Rules may be cited as the Port (Amendment No.3) Rules 2024.

Commencement.

2. These Rules come into operation on 1 October 2024.

Amendments to Port Rules.

- 3.(1) Schedule 4 of the Port Rules is amended in accordance with this rule.
