In exercise of the powers conferred on him by section 16 of the Port Operation (Registration and Licensing) Act 2005, the Minister has made the following Regulations–

## Title and commencement.

1. These Regulations may be cited as the Port Operations (Forms) Regulations 2005 and come into operation on a date to be appointed by the Minister by notice in the Gazette.

# Interpretation.

2. In these Regulations "Minister" means the Minister with responsibility for the Port and shipping.

# Forms of applications.

3. The forms for applications for licensing or re-licensing as a port operator or registration or re-registration as a port worker under the Port Operations (Registrations and Licensing) Act 2005 shall be as set out in Schedule 1.

# Forms giving notice of application.

4. The form giving notice of an application to be published pursuant to regulation 12 of the Port Operations (Registrations and Licensing) Regulations 2005 shall be as set out in Schedule 2.

#### Forms of notice of appeal and reasons.

5. The forms giving notice of appeal under regulation 29(1), and notice of reasons for decisions to be furnished by the Port Authority under regulation 29(2) of the Port Operations (Registrations and Licensing) Regulations 2005 shall be as set out in Schedule 3.

#### Forms of registers.

6.(1) The Register of port operators shall be as set out in FORM 1 of Schedule 4

(2) The Register of port workers shall be as set out in FORM 2 of Schedule 4.
