# POST OFFICE ACT. (Cap. 128).

## BRITISH COMMONWEALTH AND FOREIGN PARCEL POST (AMENDMENT) REGULATIONS, 1984.

In exercise of the powers conferred on him by sections 5, 12 and 54 of the Post Office Act, and of all other enabling powers, the Governor has made the following regulations:

#### Title and Commencement.

- 1. (1) These regulations may be cited as the British Commonwealth and Foreign Parcel Post (Amendment) Regulations, 1984.
- (2) These regulations shall come into operation on the 1st day of April, 1984.

#### Amendment of regulation 1-5 of booklet 2,of Cap. 128.

2. Regulation 15 of the British Commonwealth and Foreign Parcel Post Regulations (hereinafter called the principal regulations) is amended by omitting the words "sixty pence" and substituting the expression "£1.00".

#### Amendment of regulation 17,(1)

- 3. Regulation 17(1) (e) (ii) of the principal regulations is amended by omitting the expression "£1000", and substituting the expression "£80". Amendment of regulation 17(1) (h) (i).
- 4. Regulation 17(I) (h) (i) of the principal regulations is amended by omitting the ward "sixty", and substituting the word "eighty".

#### Amendment of regulation 18(1).

5. Regulation 18 (1) of the principal regulations is amended in proviso (c) by omitting the expression "£1000" and substituting the expression "£80".

### Amendment of regulatuon 20(2).

6. Regulation 20(2) of the principal regulations is amended by omitting the words "thirty five" and substituting the word "forty".
