POST OFFICE ACT.

**COMMONWEALTH AND FOREIGN PARCEL POST
(AMENDMENT) REGULATIONS, 1986.**

In exercise of the powers conferred on him by sections 5, 12 and 55 of the Post Office Act, and of all other enabling powers, the Governor has made the following regulations:-

Title and commencement.

1.(1) These regulations may be cited as the Commonwealth and Foreign Parcel Post (Amendment) Regulations, 1986.

(2) These regulations shall come into operation on the 1st day of March, 1986.

Amendment of Regulation 15.

2. Regulation 15 of the Commonwealth and Foreign Parcel Post Regulations (hereinafter called the principal regulations) is amended by omitting the expression "£1.00" and substituting therefor the expression "£1.20".

Amendment of Regulation 17.

3. Regulation 17(1)(h)(i) of the principal regulations is amended by omitting the words "eighty pence" and substituting therefor the expression "£1.00".

Replacement of First Schedule.

4. The principal regulations are further amended by revoking Schedule 1 thereto and substituting therefor the following new First Schedule:-

Amendment of the Third Schedule.
