POST OFFICE ACT

COMMONWEALTH AND FOREIGN PARCEL POST (AMENDMENT) (NO. 2) REGULATIONS 1996

In exercise of the powers conferred on him by section 54 of the Post Office Act, and of all other enabling powers, the Governor has made the following regulations -

Title and commencement.

1. These regulations may be cited as the Commonwealth and Foreign Parcel Post (Amendment) (No. 2) Regulations 1996, and shall come into effect on the 1st day of January 1997.

Amendment to regulation 15.

2. Regulation 15 of the Commonwealth and Foreign Parcel Post Regulations (hereinafter called "the principal Regulations") is amended by omitting the figure "£1.20" and substituting therefor the figure "£1.40."

Amendment to regulation 16.

3. Regulation 16 of the principal Regulations is amended in sub-regulation (3)(a) by omitting the words "seventy-five pence" and substituting therefor the figure "£1.00".

Amendment to regulation 17.

4. Regulation 17 of the principal Regulations is amended in sub-regulation (1)(h)(i) by omitting the figure "£1.05" and substituting therefor the figure "£1.20".

Amendment to regulation 20.

- 5. Regulation 20 of the principal Regulations is amended -
 - (a) in sub-regulation (1) -
 - (i) in paragraph (a) by omitting the word "thirty" and substituting therefor the words "thirty-five";
 - (ii) in paragraph (b) by omitting the words "thirty-five" and substituting therefor the word "sixty";
 - (b) in sub-regulation (2) by omitting the words "forty-eight" and substituting therefor the figure "£1.00".

Amendment to Schedule 1.

6. Schedule 1 to the principal Regulations is amended in Part I by omitting paragraph (b) and substituting therefor the following new paragraph -

"(b) To Morocco -

Weight not exceeding	1 Kg	£ 4.95
Weight not exceeding	3 Kg	£ 6.33
Weight not exceeding	5 Kg	£ 7.78
Weight not exceeding	10 Kg	£ 9.89
