POST OFFICE ACT. (Cap. 128).

BRITISH 'COMMONWEALTH AND FOREIGN POST (AMENDMENT) REGULATIONS, 1984.

In exercise of the powers conferred on him by sections 5 and 54 of the Post Office Act, and of all other enabling powers, the Governor has made the following regulations:

Title and Commencement.

- 1. (1) These regulations may be cited as the British Commonwealth and Foreign Post (Amendment) Regulations, 1984.
- (2) These regulations shall come into operation on the 1st day of April, 1984.

Amendment of regulation 22 of L.N. No. 84 of 1975.

2. Regulation 22 of the British Commonwealth and Foreign Post Regulations, 1975, (hereinafter called the principal regulations) is amended by omitting the words "seven" and "eight" and substituting the words "eight" and "nine" respectively.

Amendment of regulation 27.

3. Regulation 27 of the principal regulations is amended by omitting the words "sixty pence" and substituting the expression "£1.00".

Amendment of regulation 30 (2) (e).

4. Regulation 30 (2) (c) of the principal regulations is amended by omitting the word "sixty", and substituting the word "eighty".

Amendment of regulation 34.

5. Regulation 34 of the principal regulations is amended by omitting the expression "£275" from the proviso and substituting the expression "£1000". Amendment of regulation 37.

6. Regulation 37 (4) of the principal regulations is amended by omitting the words "thirty five" and substituting the word "forty".

Replacement of schedules.

7. The principal regulations are further amended by revoking the First, Second, Third and Fifth Schedules and substituting the following Schedules:
