POST OFFICE ACT

COMMONWEALTH AND FOREIGN POST (AMENDMENT) REGULATIONS 1996

In exercise of the powers conferred on him by section 54 of the Post Office Act, and of all other enabling powers, the Governor has made the following regulations -

Title and commencement.

1. These regulations may be cited as the Commonwealth and Foreign Post (Amendment) Regulations 1996, and shall come into effect on the 1st day of January 1997.

Amendment to regulation 10.

- 2. Regulation 10 of the Commonwealth and Foreign Post Regulations (hereinafter called "the principal Regulations") is amended in sub-regulation (1) by -
 - (a) omitting in paragraph (a) the figure "70" and substituting therefor the figure "82";
 - (b) omitting in paragraph (b) the figure "80" and substituting therefor the figure "93".

Amendment to regulation 22.

3. Regulation 22 of the principal Regulations is amended by omitting the words "ten" and "thirteen" and substituting therefor the words "twelve" and "fifteen".

Amendment to regulation 27.

4. Regulation 27 of the principal Regulations is amended by omitting the figure "£1.20" and substituting therefor the figure "£1.40".

Amendment to regulation 30.

5. Regulation 30 of the principal Regulations is amended in sub-regulation (2)(c) by omitting the figure "£1.05" and substituting therefor the figure "£1.20".

Amendment to regulation 31.

6. Regulation 31 of the principal Regulations is amended by omitting the figure "£18" and substituting therefor the figure "£21".

Amendment to regulation 37.

- 7. Regulation 37 of the principal Regulations is amended -
 - (a) in sub-regulation (1) by omitting the word "thirty" and substituting therefor the words "thirty-five";
 - (b) in sub-regulation (2) by omitting the words "thirty-five" and substituting therefor the word "sixty";
 - (c) in sub-regulation (4) by omitting the words "forty-eight" and substituting therefor the figure "£1.00".

Amendment to regulation 39.

8. Regulation 39 of the principal Regulations is amended by omitting the words "fifty-five" and substituting therefor the word "seventy".
