#### POST OFFICE ACT

# COMMONWEALTH AND FOREIGN POST (AMENDMENT) REGULATIONS 2008

In exercise of the powers conferred on it by section 54 of the Post Office Act, and of all other enabling powers, the Government has made the following Regulations—

#### Title and commencement.

1. These Regulations may be cited as the Commonwealth and Foreign Post (Amendment) Regulations 2008 and come into operation on 15 August 2008.

### Amendments to the Commonwealth and Foreign Post Regulations.

- 2. The Commonwealth and Foreign Post Regulations are amended-
  - (a) in regulation 27, by substituting "£2.00" for "£1.80";
  - (b) by substituting the following regulation for regulation 29–
    - "29. The Director shall, at the request of the sender of an unregistered postal packet, give a certificate of the posting of such postal packet on payment of a fee at the air-mail rate of a 10 grammes letter to the country of destination of the unregistered postal packet in question.";
  - (c) in regulation 30(2)(c), by substituting "£2.00" for "£1.60";
  - (d) in regulation 39, by substituting "eighty pence" for "seventy pence";
  - (e) in Schedule 1, by adding a new second row, after "20 grammes -28p", to read "50 grammes 50p";

- (f) in Schedule 2-
  - (i) in PART 1A, by substituting "42p" for 40p" in the three places where it appears and by substituting "17p" for "15p";
  - (ii) in PART 1B, by substituting "44p" for "42p" in the three places where it appears and by substituting "17p" for "16p";
  - (iii) in the marginal note at PART 1B, by deleting the word "other" and adding the words "(other than the United Kingdom)" before the words "and Morocco";
  - (iv) in PART 1B, by deleting "(d) for the purposes of Part 1B, countries are as following" and substituting before the heading 'EUROPEAN COUNTRIES' "For the purposes of PART 1B, the following countries are "All European Countries (other than the United Kingdom)":";
  - (v) in PART II, in paragraph (a), by deleting the table and substituting therefore—
    - "(a) Letters including letter packets—
      - (i) for the first 10 grammes or part thereof 51p
      - (ii) for every 10 grammes or part thereof after the first 10 grammes 22p
    - (b) Postcards conforming in all respects to the regulations relating thereto 51p
    - (c) Air letters conforming in all respects to the regulations relating thereto 51p."; and
  - (vi) in PART II, by deleting paragraph (b) together with the entries in ZONE 1 and ZONE 2.

## EXPLANATORY MEMORANDUM

These Regulations amend the Commonwealth and Foreign Post Regulations in order to increase the postal rates.
