In exercise of the powers conferred upon him by section 15 of the Register of Property Occupation Act 2021, the Minister with responsibility for Public Utilities has made the following Regulations-

#### Title.

1. These Regulations may be cited as the Authorised Agent Regulations 2022.

#### Commencement.

2. These Regulations come into operation on the day of publication.

### Application.

- 3. These Regulations shall apply where an agent is authorised on a landlord's behalf to deal with relevant property in occupation and an application is being made to the Registrar by an occupier pursuant to the Register of Property Occupation Act 2021.
- 4. In furtherance of the Register of Property Occupation Act 2021, a landlord and his authorised agent shall complete a Form A1 as prescribed by the Registrar.
- 5. Failure to complete a Form A1 will result in the Registrar not processing any application.
- 6. An application to the Registrar shall only be made if the relevant property is in occupation and relevant property not in occupation shall not be the subject of a Form A1.

7. A copy of Form A1 to be completed shall be materially as contained in the attached Schedule and as amended by the Registrar from time to time.
