REGULATIONS 2016**

In exercise of the powers conferred upon him by section 75 of the Public Finance (Control and Audit) Act, section 23(g)(ii) of the Interpretation and General Clauses Act, and all other enabling powers, and for the purposes of implementing into the law of Gibraltar Commission Implementing Regulation (EU) 2015/1986 of 11 November 2015 establishing standard forms for the publication of notices in the field of public procurement and repealing Implementing Regulation (EU) No 842/2011, the Minister on behalf of the Government has made the following Regulations–

Title.

1. These Regulations may be cited as the Procurement (Defence and Security Public Contracts) Regulations 2012 (Amendment) Regulations 2016.

Commencement.

2. These Regulations come into operation on the day of publication.

**Amendment of the Procurement (Defence and Security Public
Contracts) Regulations 2012.**

3.(1) The Procurement (Defence and Security Public Contracts) Regulations 2012 are amended in accordance with the provisions of this regulation.

(2) In regulation 2 for the definition of “Commission Regulation (EU) No 842/2011” substitute–

““Commission Implementing Regulation (EU) 2015/1986” means Commission Implementing Regulation (EU) 2015/1986 of 11 November 2015 establishing standard forms for the publication of notices in the field of public procurement and repealing Implementing Regulation (EU) No 842/2011, as the same may be amended from time to time;”.

(3) For every reference to “Commission Regulation (EU) No 842/2011” substitute “Commission Implementing Regulation (EU) 2015/1986”.

EXPLANATORY MEMORANDUM

These Regulations amend the Procurement (Defence and Security Public Contracts) Regulations 2012 by changing all references to “Commission Regulation (EU) No 842/2011” with “Commission Implementing Regulation (EU) 2015/1986” seeing as the former has been repealed by Commission Implementing Regulation (EU) 2015/1986 of 11 November 2015 establishing standard forms for the publication of notices in the field of public procurement and repealing Implementing Regulation (EU) No 842/2011.
