**AN ACT** to amend the Public Health Act.

**ENACTED** by the Legislature of Gibraltar.

**Title and commencement.**

1.(1) This Act may be cited as the Public Health (Amendment) Act 2007.

(2) This Act comes into operation as follows—

- (a) Section 2(1) comes into operation on the day of publication;
- (b) section 2(2), (3) and (5) are deemed to have come into operation on 1 July 2006;
- (c) section 2(4) shall be deemed to have come into operation on 1 January 2007.

**Amendments of the Public Health Act.**

2.(1) Section 19(1)(b) of the Public Health Act is amended by inserting—

- (a) after the word “drain”, the word “, manhole,”; and
- (b) after the words “is insufficient or” the words “is broken or appears to be a danger to the public, or”.

(2) Section 272 is amended by inserting after sub-section (4) the following sub-section—

“(5) Notwithstanding any contrary provision in this Part, no rate shall be payable by an individual who is an occupier of premises used exclusively for parking a motor vehicle where that individual has a freehold or leasehold interest in those premises.”.

(3) Section 277A is amended by substituting—

- (a) for “non-domestic”, “any”;
- (b) after “1<sup>st</sup> day of July 1997” insert “in respect of non-domestic hereditaments and 1 July 2006 in respect of domestic hereditaments”.

(4) Schedule 3 is amended by substituting for the definition of “special poundage” the following definition–

“special poundage” means–

- (a) in respect of paragraph (3)(a) and (b), 46 pence in the pound;
- (b) in respect of paragraph (3)(c) and (d), 55 pence in the pound;

on the full net annual value of the hereditament;”.

(5) Section 117 is amended by inserting after sub-section (6) the following sub-section–

“(7) Notwithstanding any contrary provision in this Part, no salt water rate shall be payable by an individual who is an occupier of premises used exclusively for parking a motor vehicle where that individual has a freehold or leasehold interest in those premises.”.
