**PUBLIC HEALTH ACT.**

**SEASIDE PLEASURE BOATS (AMENDMENT) RULES, 1994.**

In exercise of the powers conferred on me by section 218 of the Public Health Act, and of all other enabling powers, I have made the following rules -

**Title.**

1 . These rules may be cited as the Seaside Pleasure Boats (Amendment) Rules, 1994.

**Amendment to rule 2.**

2. The Seaside Pleasure Boat, Rules 1989 (hereinafter called "the principal Rules") are amended in rule 2 -

- (a) in the definition of "navigator" by omitting the words "pleasure boat" and substituting therefor the word "vessel";
- (b) by inserting after the definition of regulated area" the following new definition -
  - "" speed boat" means any power driven vessel capable of speeds in excess of 15 knots;"
- (c) by omitting the word "and" at the end of the definition of "surf-board";
- (d) by omitting the fullstop at the end of the definition of "unregulated channel" and substituting therefor a semi-colon;
- (e) by inserting after the definition of "unregulated channel" the following new definition -

"vessel" means anything which is mechanically propelled and is constructed or used to carry, tow or

pull persons or goods by on or in water, and any reference to a vessel shall include a reference to those persons or goods."

**Amendment to rule 4.**

3. Rule 4 of the principal Rules is amended in sub-rule (1) by omitting the words "mechanically propelled pleasure boat" and substituting therefor the word "vessel".

**Amendment to rule 5.**

4. Rule 5 of the principal Rules is amended -

- (a) in the marginal note thereto by omitting the words "mechanically propelled pleasure boats" and substituting therefor the words "vessels in unregulated channels";
- (b) by omitting the words "mechanically propelled pleasure boat" and substituting therefor the word "vessel".

**Amendment to rule 7.**

5. Rule 7 of the principal Rules is amended -

- (a) in sub-rule (2) by omitting the words "pleasure boat" and substituting therefor the word "vessel";
- (b) in sub-rule (3) by omitting the words "pleasure boat" and substituting therefor the word "vessel".

**Amendment to rule 10.**

6. Rule 10 of the principal Rules is amended by omitting the words "pleasure boat" and substituting therefor the word "vessel":

**Amendment to rule 11.**

7. Rule 11 of the principal Rules is amended by omitting the words "mechanically propelled pleasure boat" and substituting therefor the word "vessel".

**Amendment to rule 12.**

8. Rule 12 of the principal Rules is amended -

- (a) in sub-rule (1)(b) by omitting the words "pleasure boat" in the two places where they appear and substituting therefor the word "vessel";
- (b) in sub-rule (2) by omitting the word "boat" and substituting therefor the word "vessel";
- (c) in sub-rule (3) by omitting the words "pleasure boat" and substituting therefor the word "vessel".
