PUBLIC HEALTH (WASTE) (LICENSING FORMS) (AMENDMENT) RULES 2017

In exercise of the powers conferred upon it by section 337 of the Public Health Act the Government has made the following rules—

Title.

1. These Rules may be cited as the Public Health (Waste) (Licensing Forms) (Amendment) Rules 2017.

Commencement.

2. These Rules come into operation on the day of publication.

Amendment to the Public Health (Waste) (Licensing Forms) Rules.

- 3.(1) The Public Health (Waste) (Licensing Forms) Rules are amended in accordance with the provisions of this rule.
- (2) For every occasion where "can you please give" appears substitute "please provide".
- (3) For every occasion where "can you please supply" appears substitute "please provide".
- (4) For every occasion where "e-mail code" appears substitute "email".
- (5) For every occasion where "Office of the Minister for the Environment and Health, Saint Bernard's Hospital, Gibraltar" appears substitute "Environmental Agency, 37 Town Range, Gibraltar".
- (6) In paragraph 6 of Form 1 of Schedule 1 after "recovery of waste" insert-

"- storage of waste".

(7) After Form 6 of Schedule 1 insert-

"Form 7 - <u>Application For Registration To Carry Out An</u> <u>Activity Prescribed By Section 192E of the Public Health</u> <u>Act</u>

These Rules amend the Public Health (Waste) (Licensing Forms) Rules in order to include the prescribed activity of storage of waste, modernise some of the language used in the Forms, and insert new Form 7 (Application for registration to carry out an activity prescribed by section 192E of the Public Health Act) and new Form 8 (Application for renewal of a waste licence as described in section 192Q of the Public Health Act).
