INTERPRETATION AND GENERAL CLAUSES ACT

ANIMAL FEEDING STUFFS (AMENDMENT) RULES 2008

In exercise of the powers conferred on him by section 337 of the Public Health Act and section 23(g)(i) of the Interpretation and General Clauses Act, and of all other enabling powers, the Governor has made the following Rules to transpose into the law of Gibraltar Commission Directive 2006/77/EC of 29 September 2006 amending Annex I to Directive 2002/32/EC on maximum levels for organochlorine compounds in animal feed—

Title.

1. These Rules may be cited as the Animal Feeding Stuff (Amendment) Rules 2008.

Amendment of Schedule 1.

2. Chapter D of Part I of Schedule 1 to the Animal Feeding Stuff Rules 2004 is substituted by Chapter D as set out in the Schedule to these Rules.
