PUBLIC HEALTH ACT

WATER TARIFFS (AMENDMENT) REGULATIONS 2022

In exercise of the powers conferred on it by section 113(3) of the Public Health Act, and all other enabling powers, the Government has made the following Regulations—

Title.

1. These Regulations may be cited as the Water Tariffs (Amendment) Regulations 2022.

Commencement.

2. These Regulations come into operation on the 1 August 2022.

Amendment of the Water Tariffs Regulations 2010.

- 3.(1) The Water Tariffs Regulations 2010 are amended in accordance with this regulation.

(2) In regulation 2 –

- (a) delete “, during the accounting period including 1 July 2010, and every such period thereafter,”;
- (b) in paragraph (a) for “69” substitute “74.5”;
- (c) in paragraph (b)-
 - (i) for “48.7” substitute “52.6”;
 - (ii) for “£5” substitute “£5.40”;
- (d) in paragraph (c) –
 - (i) for “69” substitute “74.5”;
 - (ii) for “£5” substitute “£5.40”;
- (e) in paragraph (d)-

- (i) for “24.9” substitute “26.9”;
 - (ii) for “61.9” substitute “66.9”;
 - (iii) for “£3” substitute “£3.24”;
 - (f) delete paragraph (e);
 - (g) in paragraph (f) –
 - (i) for “138.1” substitute “149.1”;
 - (ii) for “£5” substitute “£5.40”;
 - (h) in paragraph (g)-
 - (i) for “54.8” substitute “59.2”;
 - (ii) for “£6” substitute “£6.48”;
 - (i) in paragraph (h)-
 - (i) for “69” substitute “74.5”;
 - (ii) for “£5” substitute “£5.40”.
- (3) After regulation 2 insert-
- “Weekly meter charge.**
- 2A. The sum of £1 per week is payable in respect of every water meter.”.
- (4) After regulation 3 insert –
- “Annual indexation of tariffs.**
- 3A.(1) Subject to the provisions of these Regulations, the tariffs set out in these regulations must be revised annually in accordance with the Index of Retail Prices published by the Government Statistician.
- (2) The first revision under this regulation shall apply as from 1 August 2023 and shall apply the Index of Retail Prices as at 1 April 2023, and subsequent revisions shall apply on each subsequent 1 April and apply the index of retail prices prevailing on the preceding 1 January of that year.
- (3) Any figure revised pursuant to subregulation (1) may be rounded as the Government may determine.”.
