PUBLIC HEALTH ACT

BUILDING (AMENDMENT) RULES 2023

In exercise of the powers conferred on it by sections 44, 45 and 46 of the Public Health Act, and all other enabling powers, the Government has made the following Rules–

Title and commencement.

1. These Rules may be cited as the Building (Amendment) Rules 2023 and come into operation on 1 August 2023.

Amendments to the Building Rules 2017.

- 2.(1) The Building Rules 2017 are amended in accordance with this rule.
- (2) For rule A11B substitute -

"A11B Fees payable on giving of notice, inspection, etc.

- Any application submitted for approval under the Building Rules 2017 (that does not require a planning permission under the provisions of the Town Planning Act 2018) will be subject to payment of fees in accordance with the fees contained in table below.
- (2) An "Application Fee" is payable on submission of an application for building works and an "Inspection Fee" is payable prior to completion or on completion of the building works.
