In exercise of the powers conferred upon me by Section 282 of the Public Health Act, and of all other enabling powers, I hereby make the following Order–

Title and commencement.

1.(1) This order may be cited as the Public Health (Exemption from Rates) Order 2014.

(2) This order shall have effect for the rating period commencing on the 1^{st} day of July 2012 and ending with the 30^{th} day of June 2013.

Exemption.

2. The premises specified in Column 2 of the Schedule are, while they are occupied by the persons or bodies specified respectively in Column 1 of the Schedule in relation to those premises and used for the purposes specified respectively in Column 3 of the Schedule in relation to those premises exempt from the payment of rates chargeable thereon to the extend specified respectively in Column 4 of the Schedule in relation to those premises.
