In exercise of the powers conferred upon me by Section 282 of the Public Health Act, and of all other enabling powers, I hereby make the following order –

Title.

1. This order may be cited as the Public Health (Exemptions from Rates) Order 2020.

Commencement.

2. This order shall have effect for the rating period commencing on the 1st day of July of 2016 and ending with the 30th day of June 2017.

Exemption.

3. The premises specified in Column 2 of the Schedule are, while they are occupied by the persons or bodies specified respectively in Column 1 of the Schedule in relation to those premises and used for the purposes specified respectively in Column 3 of the Schedule in relation to those premises exempt from the payment of rates chargeable thereon to the extent specified respectively in Column 4 of the Schedule in relation to those premises.
