AN ACT to amend the Public Utility Undertakings Act.

ENACTED by the Legislature of Gibraltar.

Title.

1. This Act may be cited as the Public Utility Undertakings (Amendment) Act, 1989.

Amendment to Part II.

Public Utility Undertakings (Amendment) Act, 1989.
[No. 26 of 1989.]

2. Part II of the Public Utility Undertakings Act (hereinafter called "the principal Act") is amended by inserting after section 47 the following additional sections, namely-

“Contractor companies.

47A. The Governor may by contract, on such terms and conditions as he shall think fit, authorize any company or other body (hereinafter called "the contractor company") to perform the powers and functions conferred on the Government by the provisions of this Part or such of those functions as shall be specified in the contract.

Effect of contract.

47B. Where a contract referred to in section 47A is in force, this Part shall have effect as if for the references to the Government there were substituted references to the contractor company.

Amendment to Schedule 1.

3.(1) Schedule 1 to the principal Act is amended by repealing the item entitled "Fuel cost adjustment" and substituting therefor the following item-

"Flexible Cost Adjustment Formula. The price set out in this Schedule of a unit of electricity supplied shall be adjusted upwards or downwards by such amount or by such method as the Governor, having regard to the fluctuating cost of generating or supplying electricity, may by rules prescribe."

(2) This section shall come into operation on such date as the Governor may by notice in the Gazette prescribe.

Amendment to Schedule 2.

4. Part I of Schedule 2 to the principal Act is amended by inserting in its appropriate alphabetical position the following new paragraph-
