### **Title.**

1. These regulations may be cited as the Ship Agents (Forms and Fees) Regulations, 1987.

### **Fees.**

2. The amount of the fee required by section 10 to accompany an application for registration as a ship agent shall be £25.

### **Particulars for registration.**

3. The register of ship agents shall contain the following particulars:-

- (a) the full name of the ship agent including, where applicable, the business name as defined in the Business Names Ordinance;
- (b) the address and telephone and telex number of the permanent place of business of the ship agent in Gibraltar;
- (c) if ship agent is a firm the names and addresses of its partners;
- (d) if ship agent is a company the names and addresses of its directors.

### **Forms.**

4. The forms set out in the Schedule or forms as near thereto as circumstances may require shall be used for the several matters specified therein.
