SHOP HOURS ACT.

SHOPS (DAYS AND TIMES OF OPENING) (AMENDMENT) REGULATIONS, 1990.

In exercise of the powers conferred upon him by section 16 of the Shop Hours Act, and of all other enabling powers, the Governor has made the following regulations—

Title and commencement.

1. These regulations may be cited as the Shops (Days and Times of Opening) (Amendment) Regulations, 1990 and shall be deemed to have came into effect on the 22nd day of November 1990.

Amendment to regulation 9.

2. Regulation 9 of the Shops (Days and Times of Opening) Regulations, 1990 (hereinafter called "the principal Regulations") is amended by inserting the following two new sub-regulations -

"(4) Any shop which exhibits in a conspicious position a valid permit granted by the Commissioner of Police in accordance with sub-regulation (5) may, notwithstanding regulation 3, remain open on the additional days and during the additional hours specific in that permit.

(5) When an application is made for a shop to remain open on days or times other than those permitted by these regulations and such application is made on. the form prescribed in the Schedule to these regulations, the Commissioner of Police may in his discretion irant a permit valid for a period of 3 months specifying therein the additional days and hours on which the shop may open and the day an which the permit expires and such permit shall be in the form prescribed in the Schedule.".
