Smoking Prohibition (Smoking on GHA Grounds) Regulations 2018

In exercise of the powers conferred on him by section 5 of the Smoke-Free Environment Act 2012, the Minister has made the following Regulations—

Title.

1. These Regulations may be cited as the Smoking Prohibition (Smoking on GHA Grounds) Regulations 2018.

Commencement.

2. These Regulations come into operation on 1 October 2018.

Smoking prohibited on GHA grounds.

- 3.(1) Smoking is prohibited in all areas of GHA grounds.
 - (2) The prohibition in subregulation (1)-
 - (a) is in addition to any relevant prohibitions in the Act that apply to GHA grounds; and
 - (b) is subject to-
 - (i) the exemptions contained in subregulation (4); and
 - (ii) any designations made in accordance with section 8(3)(a) of the Act which are approved by the Minister in writing.
 - (3) For the purposes of these Regulations-
 - "GHA" means the Gibraltar Health Authority established by section 3 of the Medical (Gibraltar Health Authority) Act, 1987;
 - "GHA grounds" means land in the vicinity of buildings situated on GHA premises and associated with that premises, such land being shaded in green in the plans included in the Schedule to these Regulations; and
 - "GHA premises" means premises provided or maintained by the GHA listed in the Schedule to these Regulations, and includes, for the avoidance of doubt, premises listed in that Schedule provided or maintained by an institution or other entity under the control of the Authority, for the provision of residential services for the elderly.








