**SOCIAL SECURITY (EMPLOYMENT INJURIES INSURANCE)
(AMENDMENT OF BENEFITS) ORDER 2007**

In exercise of the powers conferred on me by section 55 of the Social Security (Employment Injuries Insurance) Act, I have made the following Order—

Title and commencement.

1.(1) This Order may be cited as the Social Security (Employment Injuries Insurance) (Amendment of Benefits) Order 2007.

(2) This Order shall be deemed to have come into operation on 1 September 2007.

Application.

2.(1) The rates of benefits provided for by the amendments effected by this order (other than the benefits specified in sub-paragraph (2)) shall apply only in respect of accidents that occur on or after 1 September 2007.

(2) The following rates of benefit under the Act shall be payable irrespective of the date of the accident—

- (a) the rates of disablement pension set out in Schedule 4;
- (b) the rates of dependents' allowances set out in Part II of Schedule 2 for beneficiaries entitled to a disablement pension;
- (c) the rates of death pension and dependents' allowances set out in section 19; and
- (d) an increase in disablement benefit resulting from the review of an assessment under section 37(2).

Amendment of Section 16.

3. Section 16(2) of the Act is amended by omitting “£31.80” and “£63.60” and substituting “£36.90” and “£73.80” respectively.

Amendment of Section 19.

4. Section 19 of the Act is amended—

- (a) in sub-section (1), by omitting “£42.70” and substituting “£49.50”;
- (b) in sub-section (2) (a) by omitting “£46.40” and “£21,350” and substituting “£53.80” and “£24,770” respectively;
- (c) in sub-section (2) (b), by omitting “£21,350” and substituting “£24,770”.

Amendment of Section 20.

5. Section 20 of the Act is amended by omitting “£21.30” and substituting “£24.70”.

Amendment of Section 21.

6. Section 21 of the Act is amended—

- (a) in sub-section (4)(a), by omitting “£21.80” and “£32.40” and substituting “£25.30” and “£37.60” respectively;
- (b) in sub-section (4)(b), by omitting “£2,390” and substituting “£2,770”.

Amendment of Section 22.

7. Section 22 (1) of the Act is amended by omitting “£2,390” and substituting “£2,770”.

Amendment to Schedule 2.

8. Schedule 2 to the Act is amended by omitting Parts I and II, and substituting the following Parts—
