SOCIAL SECURITY (INSURANCE) ACT

**SOCIAL SECURITY (INSURANCE) ACT (AMENDMENT OF
CONTRIBUTIONS) ORDER 2009**

In exercise of the powers conferred upon me by section 52 of the Social Security (Insurance) Act and with prior approval by resolution of the Gibraltar Parliament, I make the following Order—

Title and commencement.

1. This Order may be cited as the Social Security (Insurance) Act (Amendment of Contributions) Order 2009 and comes into operation on the day of publication.

Amendment of Schedule 1.

2. Schedule 1 to the Act is amended by omitting everything after the heading, and substituting the Schedule to this Order.

SCHEDULE

Combined Social Insurance and Other Contribution Rates.

Rate of Contributions for an Employed Person.

Employee - 10% of Gross Earnings.

Subject to a maximum contribution of £1,234.48 per annum.

Contributions are payable weekly subject to a minimum of £5.00 per week and a maximum of £23.74 per week.

Married Women.*

£12.36 per week.

*This rate only applies to those married women who prior to 1 January 1985 elected not to pay contributions to the Social Insurance Scheme.

Employer - 20% of Gross Earnings.

Subject to a maximum contribution of £1,558.44 per annum.

Contributions are payable weekly subject to a minimum of £15.00 per week and a maximum of £29.97 per week.

Where the person employed is 60 years or over or one who has retired at age 55 by operation of law, only the employer's share of the contribution is payable.

Rate of Contribution for a Self-Employed Person - 20% of Gross Earnings.

Subject to a maximum contribution of £1,426.36 per annum.

Contributions are payable weekly subject to a minimum of £10.00 per week and a maximum of £27.43 per week.

Gibraltar Regiment.

Employee Contributions: £13.86 per week.

Employer Contributions: £18.67 per week.

Apportionment of Contributions.

All contributions collected with effect from 1 July 2009 shall be apportioned as follows:

Gibraltar Health Authority – GPMS	70.00%
Statutory Benefits Fund	30.00%
Total	100.00%
