# NON-CONTRIBUTORY SOCIAL INSURANCE BENEFIT AND UNEMPLOYMENT INSURANCE ACT. (Cap. 113).

# NON-CONTRIBUTORY SOCIAL INSURANCE BENEFIT AND UNEMPLOYMENT INSURANCE (AMENDMENT OF BENEFITS ) ORDER, 1984.

In exercise of the powers conferred on him by section 18 of the Non-Contributory Social Insurance Benefit and Unemployment Insurance Act, and of all other enabling powers, and with the prior approval by resolution of the House of Assembly, the Governor has made the following order:

#### Title and commencement.

- 1. (1) This order may be cited as the Non-Contributory Social Insurance Benefit and Unemployment Insurance (Amendment of Benefits) Order, 1984.
- (2) Paragraph 2 of this order shall come into operation on the 25th day of December, 1984.
- (3) Paragraph 3 of this order shall come into operation on the 26th day of December, 1984.

#### Amendemnt of Second Schedule to Cap. 113.

2. The Second Schedule to the Non-Contributory Social Insurance Benefit and Unemployment Insurance Act Schedule (hereinafter called the Act) is amended by omitting everything after the heading "Second Schedule", and substituting the following:
